STATE APPROPRIATION LAW (As Revised)

LAW NO. 1, 2020

A LAW TO APPROPRIATE THE SUM OF ONE HUNDRED AND TWENTY-FOUR BILLION, THREE HUNDRED AND FIFTY-SEVEN MILLION NAIRA ONLY (N124,357,000,000) FOR THE SERVICES OF THE GOVERNMENT OF JIGAWA STATE OF NIGERIA FOR THE PERIOD OF 1st JANUARY TO 31st DECEMBER, 2020.

ENACTED BY the Jigawa State House of Assembly:

1. Citation and Commencement.

This Law may be cited as State Appropriation Law, 2020 and shall be deemed to have come into operation on the 1st day of January, 2020.

2. Issue and Appropriation of the sum of N124,357,000,000

- 1) The Accountant General of Jigawa State may on the warrant signed by the Governor, pay out of the Consolidated Revenue Fund of the State during the period ending 31st December, 2020 the sum specified by warrant not exceeding the aggregate sum of One Hundred and Twenty-Four Billion, Three Hundred and Fifty-Seven Million Naira being the total amounts set forth opposite each of the code of the Schedule to this Law.
- 2) The said sum shall be appropriated for the purposes and in the manner set out in the schedule to this Law.

3. Lapsing of Un-Issued Amount.

The money granted by this Law are provided for the services in respect of which money will become payable within the quarter ending 31st December, 2020 and any balance thereof un-issued on the said 31st December, 2020 shall lapse and shall not be available for making any payment in the subsequent month. This is brought pursuant to section 121 of the Constitution of the Federal Republic of Nigeria 1999 (as amended).

4. Repeal of State Appropriation Law 2019


The State Appropriation Law, Law No. 11, 2019 is repealed.
