APPROVAL FOR ADOPTION OF NATIONAL CHART OF ACCOUNTS BY THE LOCAL GOVERNMENTS IN JIGAWA STATE.

The State Executive Council at its meeting held on Monday 24th March, 2025 **DELIBERATED** on the memorandum presented by Commissioner of Commerce, Industry, Cooperatives and Tourism on your behalf, on the request for approval for the Adoption of National Chart of Accounts by the Local Governments in Jigawa State.

2/ Council **CONSIDERED** the memorandum and **NOTED**:

- i) That, HOPE Programme is a Multi-Million Dollar World Bank IDA Facility to governance issues that constrain the effective delivery of Education and Health in Nigeria;
- ii) That, the programme has three (3) components namely HOPE-GOV, HOPE-PHC and HOPE-EDU;
- iii) That, the programme has an explicit Eligibility Criteria for participation and Disbursement Link Indicators for accessing funds;
- iv) That, the specific Disbursement Link Indicators for the 2025 fiscal year for which efforts are ongoing to ensure that they are all met before the end of the deadline;
- v) The progress that has been achieved with regard to the adoption of the National Chart of Accounts by the LGAs since last year.

3/ Council **APPROVED** the comprehensive adoption of the National Chart of Accounts for both annual budget preparation and the preparation of annual final statements by all the Local Governments in the State.

4/ **DIRECTED** State Universal Basic Education Board (SUBEB) and the Ministry of Health to collaborate with FCDO programs providing them with technical support to ensure their respective Disbursement Link Indicators are met within the required timelines.
